COPYRIGHT **COPYRIGHT TRANSFER** A rights regime that grants exclusive rights The document where the original copyright holder to creators of original works, including literary, grants any or all the rights over a work to a person artistic, musical, and other creative expressions, or entity that then become the new holder. allowing them to control how their works are used and distributed. **EXPLOITATION RIGHTS DISTRIBUTION RIGHTS** The exclusive rights granted to authors to decide The right to make the work accessible to the public through physical copies. how to use a work including, but not limited to, reproduction, distribution and communication and to make derivative works. \_\_\_\_\_ **FIRST PUBLICATION RIGHTS INSTITUTIONAL RIGHTS RETENTION POLICY** A publisher's exclusive right to publish a work for the first time. An expressed position setting out the practice of retaining sufficient rights for academic works of an institution's employees to make the work immediately openly accessible and reusable. \_\_\_\_\_ **PUBLIC COMMUNICATION RIGHT REPRODUCTION RIGHTS** The right to make the work publicly available The right to make copies of the work. without the need to distribute physical copies. **SECONDARY PUBLISHING RIGHTS RIGHTS RETENTION** The right to republish a work elsewhere The action to retain sufficient rights for once it has been published for the first time academic works to enable them to be openly immediately or after a period of time. accessible and reusable preferably immediately. This right, included in some national European legislations, is granted to authors when publishing results from publicly-funded research, regardless of the contract or transfer agreement they might have signed with a publisher.

Where works are not protected by copyright and are freely available for anyone to use, modify, or distribute without obtaining permission.

An element in certain Creative Commons licences that requires derivative works to be licensed under the same or a compatible licence.
