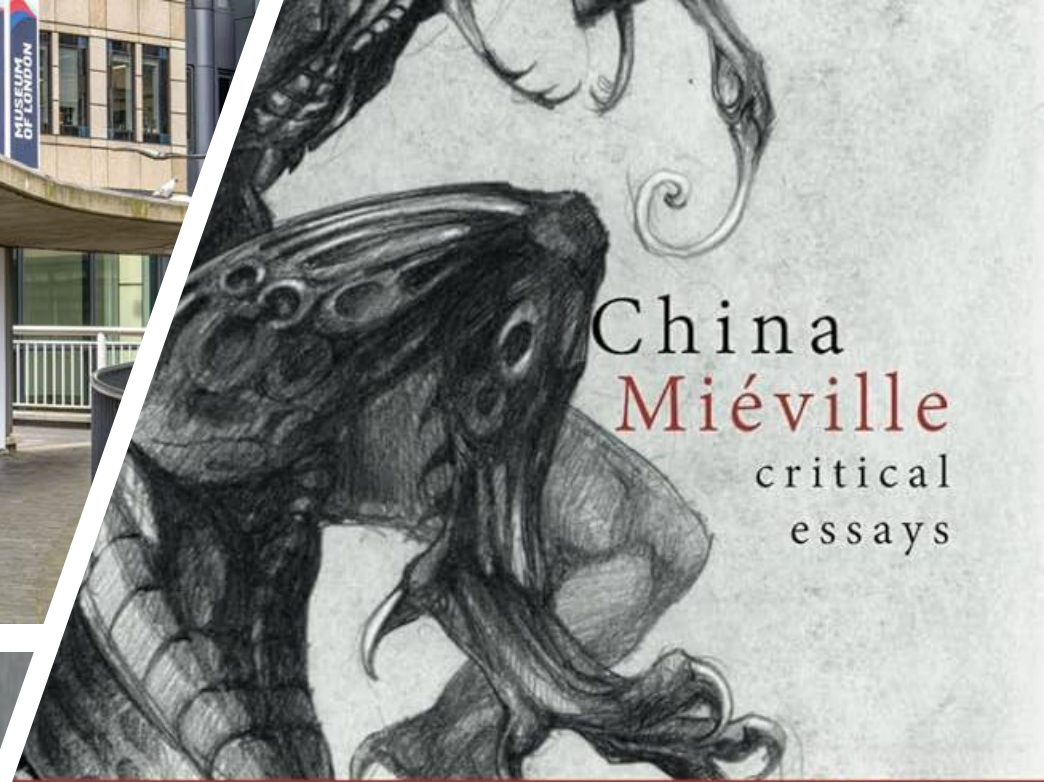

We are the Open Library of Humanities.



- Originally launched in 2013 as an international project movement of scholars, librarians, programmers, and publishers. We wanted to rebuild an unfair system in which corporate publishers make huge profits from publicly funded research by selling it back to universities in subscription packages.
- By 2015, the Open Library of Humanities had become a scholar-led publisher offering a not-for-profit route to open access.

For free. For everyone. Forever.

We believe that scholarship should be **academic-led and community-owned** – our goal is to liberate university research from commercial control. We've spent 10 years building a **sustainable business model** for funding diamond open access publishing, proving that it can be affordable and scalable.





33+ diamond OA journals.

We launched as a publisher in 2015 with just 7 journals. HSS editors apply to join our programme and flip their journals OA from subscription models (particularly Wiley, Elsevier, Springer and Taylor & Francis).



We developed our own software.

We developed our own in-house publishing platform to ensure our technology is open source & protected against commercial acquisition. Janeway is copyleft licensed under the Affero General Public License (AGPLv1).



Funded by 350+ libraries.

Our library members support our publishing activities and inform the growth of the OLH via a community governance structure.



Our platform is growing quickly.

5.3 million OLH journal articles & website views in 2024. c. 400 journals using Janeway (that we know about!)

35+ university press and publishing partners, including California Digital Library, UCL Press, University of Michigan Press, Iowa State Digital Press, Society for Clinical Data Management, University of Arizona Libraries.

How it works.

01

Many universities and libraries contribute small, affordable sums.

Keeping our basic membership rates low helps libraries keep their costs under control. For libraries operating with larger budgets for open-access publishing, we can offer higher-tier membership rates.



These funds cover OLH publishing expenses and journal funding.

By diverting small sums from their commercial open-access budgets, OLH partner libraries provide the financial support we need to expand our portfolio of journals and build open-source publishing technologies that benefit the entire academic community.

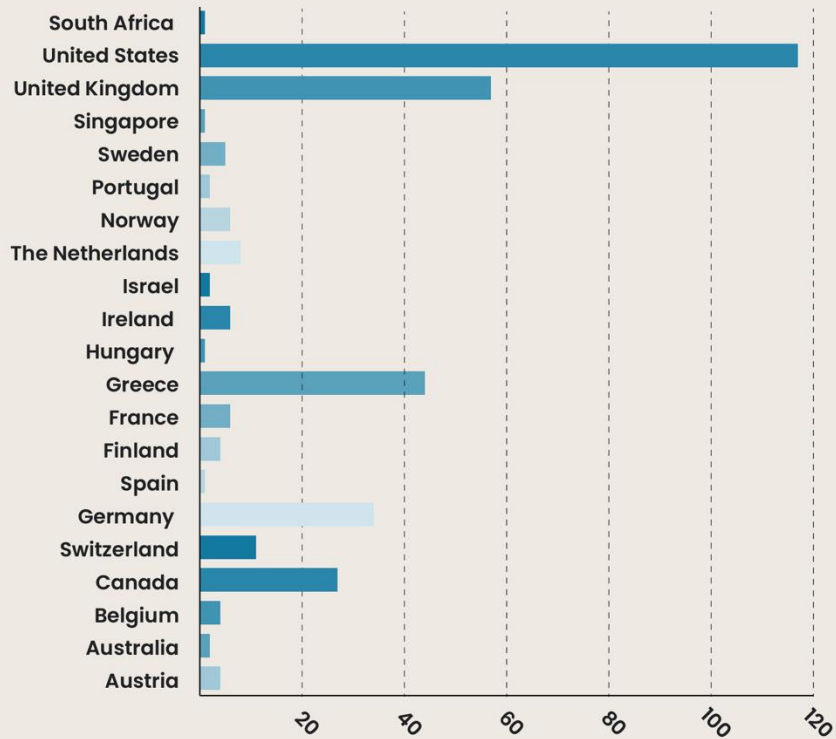
OLH journals publish research that is archived, secure, and free to access.

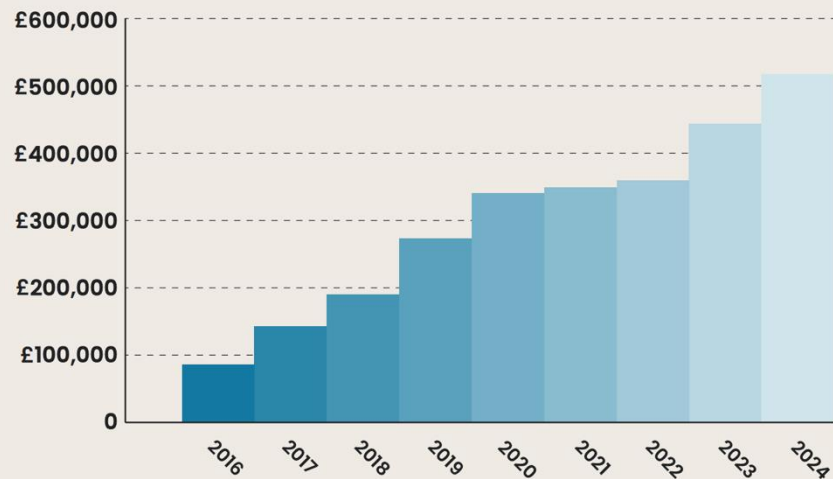
No. of library members by country.



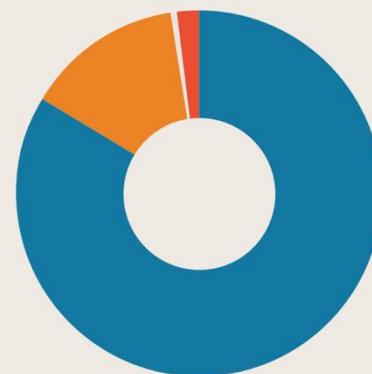
Average membership cost (£).



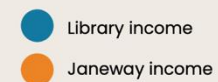
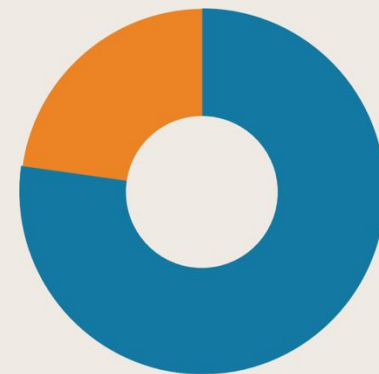
Library income.



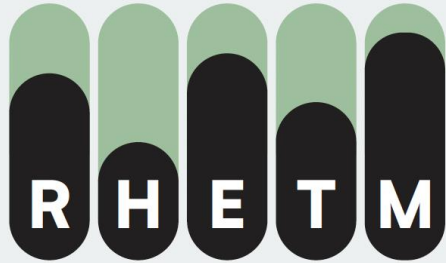
OLH expenses in 2023-24.



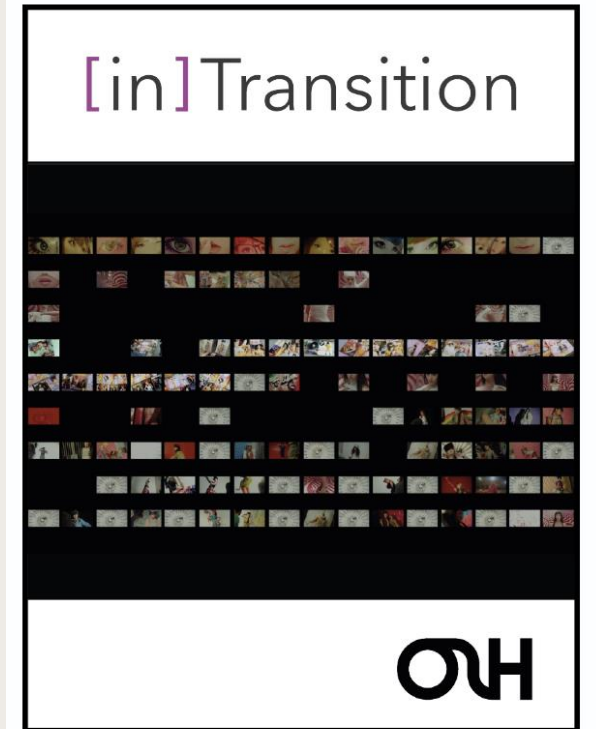
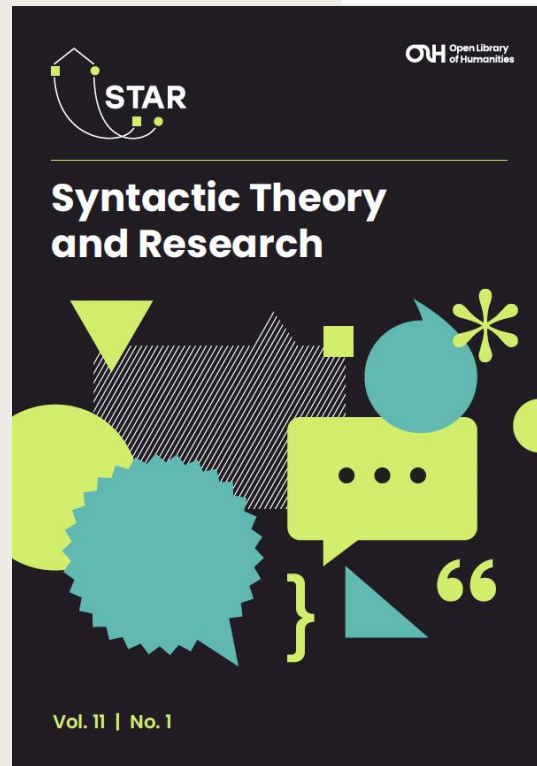
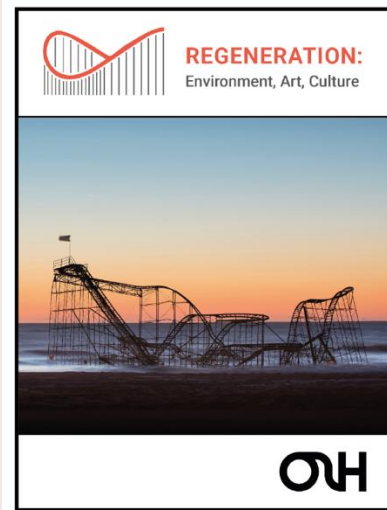

Community-based governance.

In October 2023 we relaunched the **Library Board**, with 14 elected university and professional librarians.

The Library Board represents the interests of all OLH library members.

Through regular input on our processes and strategy, the Board ensures that the **community governance** of the OLH is embedded in all that we do.

The Library Board also **advises the OLH team** on matters relating to library funding, indexing, discoverability, and bibliodiversity.

A world-leading open-source digital publishing platform.

Our dedicated in-house software engineers have built a leading platform for journal hosting, migration, manuscript submission, review, copy-editing, and typesetting. The platform is called Janeway.

How member support drives OLH development.

Standard-level OLH membership sustains our publishing activities and helps build open-source publishing technologies that benefit the entire academic community.

Higher-level OLH membership helps us expand. We use these funds to rescue high-profile titles that are at risk from commercialisation (which threatens their academic integrity) as well as journals that are ceasing publication due to austerity cuts to humanities research funding.

Challenges to growth

Reaching decision makers.

Many editors aren't decision makers and report to steering committees or society governance structures.

Journal ownership.

Many journals don't own their IP. Flipping involves setting up a new title, establishing authenticity, persuading editors to quit the zombie journal.

Migrating back content.

Journal archives are often only available in proprietary formats, which require coding work to access.

Managing academic expectations.

Years of commercial provision means editors expect some customer services that not-for-profits cannot provide.



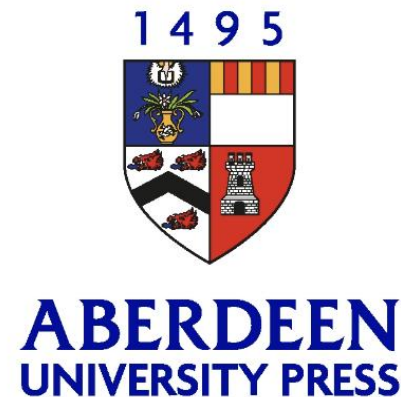
Redistribution.

We know that OA library budgets are under pressure. We don't want to beg for money that doesn't exist. We want to **work together with librarians** to talk about redistributing funds for commercial journal packages.

- How can librarians and university-based publishers work together to **divest from Transformative Agreements** (TAs)?
- How can OLH support librarians through **academic outreach**?
- What role can **university leaders** play in this transition?
- What role can **open access funders** play?

This proposal has been designed by librarians, scholars, and university-based publishers.

01 **Cost effective.**

Not-for-profit model of cost recovery – no shareholders, no surplus, transparent pricing.

02 **Scalable.**

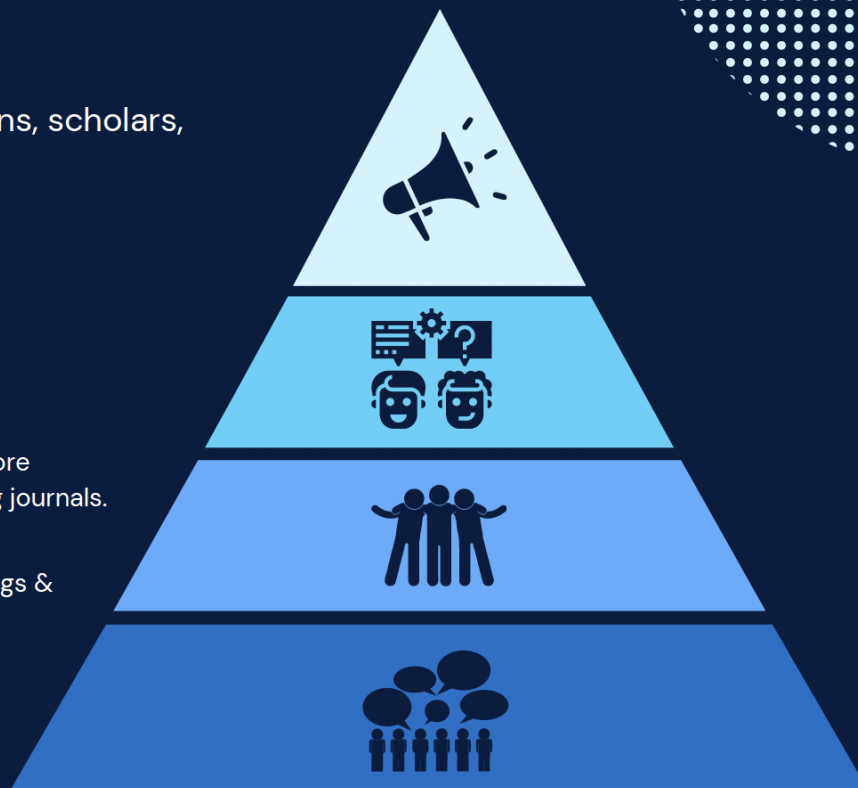
12+ publishers at launch, open applications for more publishers to join. Capacity & expertise in flipping journals.

03 **Sustainable.**

Publishers share resources, make efficiency savings & preserve bibliodiversity.

04 **Mission aligned.**

Libraries divest from commercial TAs & invest in academic-led organisations & infrastructure. Spending doesn't exit HE sector.
