### Challenges for libraries in supporting infrastructures

Squeezed budgets with competing demands

Absence of enabling strategy

Finance or procurement restrictions

Research culture with competing pressures and need for academic buy-in

### What if we can't solve this problem?

Increasing domination by a decreasing number of commercial actors

A lack of diversity in the system could stifle innovation

A scholarly communication system built solely on competition rather than cooperation

Potential lack of interoperability, accountability and transparency

Our budgets will continue to be squeezed



#### Potential solutions

Lobby senior university leaders:

- Collaborate to create an enabling institutional strategy for open research
- Share the eyewatering figures on what's being spent to facilitate OA publishing
- Support efforts to improve research culture bring attention to initiatives such as COARA and push for incentives that reward researchers for open research practices.



#### Potential solutions

- Double our efforts with advocacy to our academic communities, highlighting success stories.
- Find the Open Research champions from across all disciplines and build a community of practice to amplify the message.
- Work across institutions to increase capacity, build reputation and influence, eg Open Institutional Publishing Association (OIPA).
- Remove friction where possible to increase uptake of open research practices, eg rights retention.
- Build a consensus that supporting open infrastructure is essential, not a 'nice to have'.






## What infrastructures can do to enable institutional support

- Contract to deliver specific developments or functionality, e.g.
   reclassifying DOAJ with a German Consortium, or the OA Journals Toolkit with Jisc in the UK
- Deeper collaboration based on national support, e.g. Royal Danish Library
- Being flexible with procurement and invoicing
- Contributions are more than just financial you can support through board membership and volunteering

#### Call to action

- Focus on our shared values and goals see infrastructures as an extension of the library
- Lobby senior university leadership to ensure they understand the importance of open infrastructure
- Move from transaction to investment
- Develop a Library-wide vision for open research which will guide/steer prioritisation and processes
- Look for ways to actively engage boards, groups, responding to consultations
- Bring in finance and procurement offices so they understand the wider context
- Share the responsibility of finding solutions to this joint problem
